# ON FULFILLMENT OF RIGHTS OF PEOPLE WITH DISABILITIES IN THE UNIVERSITAS ISLAM INDONESIA

# RECTOR OF THE UNIVERSITAS ISLAM INDONESIA,

# **CONSIDERING**

- : a. that every Person with Disabilities has the right to inclusive and special education and also to get proper accommodation as a disability right;
  - b. that education providers may not discriminate against persons with disabilities in fulfilling the right to education;
  - c. that based on the considerations as referred to in letter a, it is necessary to establish a Regulation of the Chancellor of the Islamic University of Indonesia concerning the Fulfillment of Inclusive Campuses within the Universitas Islam Indonesia;

TO ENACT : RECTOR REGULATION OF THE UNIVERSITAS

ISLAM INDONESIA CONCERNING FULFILLMENT OF THE RIGHTS OF PEOPLE WITH DISABILITIES IN THE ENVIRONMENT OF THE UNIVERSITAS ISLAM

**INDONESIA** 

# Article 1

In this regulation what is meant by:

- 1. University is an Universitas Islam Indonesia as a Higher Education Institution organized by the Foundation for the Waqf Board of the Universitas Islam Indonesia.
- 2. Study Program is a unit of educational and learning activities that has a certain curriculum and learning method in one type of academic education, professional education, and/or vocational education.
- 3. The Chancellor is the Chancellor of the University.
- 4. Persons with Disabilities are any person who experiences physical, intellectual, mental, and/or sensory limitations in the long term which in interacting with the environment may experience obstacles and difficulties to participate fully and effectively with other citizens based on equal rights.
- 5. Fulfillment is an effort made to fulfill, implement, and realize the rights of Persons with Disabilities.
- 6. Rights of Persons with Disabilities are basic rights owned by Persons with Disabilities that are recognized under this regulation.

# **Article 2**

Fulfillment of the Rights of Persons with Disabilities within the University aims to:

- a. To realize full and equal respect for, promotion, protection and fulfillment of human rights and basic freedoms for Persons with Disabilities;
- b. Ensure services for Persons with Disabilities normatively, infrastructure, as well as behavior and resources; and
- c. Ensuring the protection of Persons with Disabilities from neglect, exploitation, harassment and all acts of discrimination, as well as violations of human rights.

#### Article 3

Rights of Persons with Disabilities within the University include:

- a. The right to clear and supportive policies and norms;
- b. The right to infrastructure, technology and communication; and
- c. Rights to behavior and service resources.

# Article 4

Rights to policies include:

- a. Admission policy;
- b. Academic policy; and
- c. Disciplinary norms enforcement policies.

# Article 5

- (1). In the event of a disciplinary violation that results in loss or makes the Person as a direct victim, the disciplinary sanction may be considered to be aggravated.
- (2). The disciplinary sanctions as referred to in paragraph (1) include the enforcement of student discipline and employee discipline.

# Article 6

The Right to facilities as referred to in Article 3 letter b, includes but is not limited to:

- a. Physical access facilities such as ram, inclined plane, elevator and other physical facilities.
- b. Running text that shows the direction or function of space, up to a sign language translator.

#### Article 7

- (1). The construction of campus buildings must take into account the principles of Universal Design which take into account the needs and abilities of Persons with Disabilities.
- (2). The Universal Design as referred to in paragraph (1) includes:
  - a. equal use of space;
  - b. safety and security for all;
  - c. easy access without obstacles;
  - d. easy access to information;
  - e. independent use of space;
  - f. efficiency of user efforts; and
  - g. ergonomics for size and space.
- (3). If the building already exists, it will be gradually adjusted so that it can meet the access needs of Persons with Disabilities.

#### Article 8

The Right to behavior and service resources as referred to in Article 3 letter c, includes but is not limited to:

- a. Guaranteed fair and equal service and treatment;
- b. Guaranteed friendly attitude and behavior by the academic community in the campus environment.

## Article 9

(1). In order to realize the service for the rights of Persons with Disabilities in the environment campus, a service unit for Persons with Disabilities is formed at the University level.

- (2). The head of the service unit for Persons with Disabilities is responsible to the Chancellor.
- (3). The service unit for Persons with Disabilities has the following duties and authorities:
  - a. improve the competence of educators and education personnel in higher education in dealing with students with disabilities;
  - b. Coordinate each work unit in the tertiary institution in meeting the special needs of students with disabilities:
  - c. supervise and evaluate the implementation of appropriate accommodation;
  - d. provide counseling services to students with disabilities;
  - e. conduct early detection for students with indicated disabilities;
  - f. refer students with indicated disabilities to doctors, psychologists, or psychiatrists; and
  - g. provide socialization of understanding disability and inclusive education systems to educators, education staff, and students.

# Article 10

The service unit for Persons with Disabilities as referred to in Article 9 is formed no later than one year after this regulation is enacted.

### Article 11

This regulation is effective from the date of stipulation.
